- 4) The firm should quote the rate per Kg as per the commercial bid format mentioned in the Annexure I. The quotation not received as per Annexure I will be summarily rejected. The total quantity of the items will be considered as per the actual weightment.
- 5) The tenderers are advised to inspect items earmarked by the office for sale/disposal before submitting their tender. The intending bidders may verify and satisfy themselves with the quantities as well as quantity / condition of materials lying at the site and submit their tender accordingly. No claim whatsoever w.r.t. the quantities/quality/condition of said materials or otherwise will be entertainable/payable after submission of bid by intending tenders.
- 6) The successful bidder shall lift the material and clear the site within 5 working days from the acceptance of the bid.
- 7) Transportation charges and material handling charges including loading will be borne by the purchaser.
