Consultants to secure Statutory Clearances required for NABI
Campus Development

Sealed tenders are invited from experienced Consultants for securing the following statutory clearances for NABI campus development Project in Sector 81, S.A.S Nagar, District Mohali:

1. Permission from State/District authority for abstraction of ground water for infrastructure/ projects from Deputy Commissioner of the District/ Area/G.O.I.
2. EIA clearance (Environment Impact Assessment clearance) from State Expert Appraisal Committee/GOI.
3. Clearance from State Pollution Control Board for setting up of the Institutes/ Centres/Projects.
4. Sanction of Power Connection from State Electricity Board.
5. Clearance from Chief Electrical Inspector for installation of Electrical Equipment & testing.
6. Clearance form DAE for storing/ handling of radio-active material, if any.
7. Clearance from Chief Inspector Explosive, Nagpur for storing or handling of explosive material.
8. Clearance from Chief Inspector Boilers of the State for handling, installation and testing of high pressure equipment.
9. Any other statutory clearance required for the Institute.

The consultant should have thorough knowledge & experience in preparing the case for submission and follow up of the same till statutory clearances from Central/State Govt. is secured. The Tenderer must have got cleared two similar projects in the last 2 years period from the competent authorities which would be taken as minimum criteria for the award of the contract. **Tenderer can submit Tender for all the items of statutory clearances, mentioned above, or part thereof.**

The tender should submit the bid in two envelopes, viz. (i) **First** envelope inscribing on top "**Technical bid**" containing all the technical and administrative staff with their experience & Bio-Data associated with the tenderer consultants; minimum time frame to get the clearances; and other relevant information regarding competency level etc, strengthening their case for the award of the contract; and (ii) **Second** envelope shall inscribe on top as "**Financial bid**" and will contain the detailed breakup of prices to be charged as per the completion date of each event, leading to the clearance of the project. The financial bid of only those consultants will be opened subsequently whose technical bid is approved by the committee of NABI.

The tenders may be submitted along with the Earnest Money of Rs.50,000/- (Fifty thousand only), in the form of DD drawn in favour of "National Agri-Food

Biotechnology Institute, Mohali”(enclosed with the Technical bid in the first envelope) in the O/o the undersigned, at the address mentioned above, upto 3.00 pm on 05-08-2010 and the technical bid will be opened at 3.30 pm on the same day in the presence of the tenderer, if any. Tender received without EMD will be summarily rejected.
