#### Essential Qualification (EQ\*)

\* Provisionally eligible candidates have to produce all original documents in support of his/her candidature viz. proof of date of birth, all educational certificates, experience certificates (with proper date and duration), Photographs, Publication records etc. at the time of appearing for presentations/interview. In the absence of the same, the candidature shall not be considered for further selection process under any circumstance.
