- 1. The selected candidate will be paid initial pay with other allowances apply as per Central Govt. Rules/ Bye laws and Recruitment rules of NABI. Candidates working in Government Organizations/PSUs/Autonomous bodies/ Universities/Research Organizations should apply through proper channel along with ACRs and Vigilance / Cadre Clearance for consideration. The benefit of pay protection will be given to the selected candidate from Government Organizations/PSUs/Autonomous bodies/ Universities/Central & State Research Organizations.
- 2. Appointment will be on direct selection basis...
- 3. As per the instructions of Govt. of India, there will be no interview for the Group C and Group B (Non-Gazetted) posts. However, the candidates will be required to appear in Written Test as per schedule to be notified later.
- 4. The selection will be made through written test only. In the event, if none of the written test candidate is found suitable the post(s) will not be filled.
- 5. The appointee would be on probation for a period of two years which may be extended or curtailed at the discretion of the Competent Authority.
- 6. At the time of joining, the candidate will have to withdraw any other application(s) that he/she may have submitted elsewhere for employment.

- 11. Upper age limit shall not applicable for existing employees of the institute or any employee of Department of Biotechnology (GOI).

The period of experience in the discipline/ area of work described in the Essential qualification shall be counted after the date of acquiring the minimum prescribed educational qualifications for the Group/ Grade. Self-Attested copy of experience certificate and other requisite documents should be enclosed.
- 13. Mere fulfillment of educational qualifications and experience does not entitle a candidate to be called for written test. The duly constituted Screening Committee will adopt its criteria for short-listing the candidates.
