- 2. The training period should be for 4 to 6 months between July to Dec-2022. The training will be conducted at NABI's main campus and training project should be within scope of NABI mandates.
- 3. The training would be in one of the four areas i) <u>Agricultural Biotechnology</u> ii) <u>Computational Biology and Bioinformatics</u> iii) <u>Food Science and Technology</u> and iv) <u>Nutrition Science and Technology</u>. Apart from lab works, trainee may be required to involve in research works in field and growth/tissue-culture chambers for growing and testing research materials.
- 4. A registered students from any branches of life sciences/basic sciences/applied sciences/engineering institutes/colleges/universities pursuing under graduation or post-graduation or having degrees in the above are eligible for NABI's training programs.
- 5. NABI may arrange accommodation in hostels or guest house (shared) at NABI's prescribed rate, if available.
- 6. NABI will not reimburse any medical claims that incurred during training.
- 7. The number of trainees to be required will depend on the scientist's requirement from time to time.

- 8. The selection of trainees shall be through screening cum selection committee based on academic merit and experience.
- 9. Opportunities are also available for short-term or long-term training sponsored programs by government agencies such as DST, DBT, INSA, NASI, etc. without any fee.
